In view of recent decisions of the Government, India is shifting from a cash dependent to a less cash economy. University Grants Commission looks forward to an active participation of educational institutions in accomplishing this challenging task. In this matter, a communication has been received from the Ministry of Human Resource Development (MHRD), Department of Higher Education advising all autonomous institutions of MHRD as follows:

*"It is hereby advised that for all payments to be made to any of the institutions associated with MHRD for any purpose, Draft and Pay Order should not be insisted upon till further orders. Instead, on line payments including RTGS and NEFT or Cheque, with the valid ID of the persons submitting the Cheque should be accepted. Further all institutions should prepare a road map for transition to cashless mode for all financial transaction."*

Accordingly you are requested to comply with the advisory of the Ministry of Human Resource Development.
