ORDER:

Orders have been issued in the G.O third read above, enhancing the reservations for Scheduled Tribes from 6% to 10% in admissions into educational institutions and in the matter of appointments to the services under the State.

2. In pursuance of the said orders, Government have decided to amend the Telangana State and Subordinate Service Rules, 1996 suitably.
3. Accordingly, the following notification shall be published in an Extra Ordinary issue of the Telangana Gazette dated:09.11.2022:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and all other powers hereunto enabling, the Governor of Telangana hereby makes the following amendments to the Telangana State and Subordinate Service Rules, 1996, issued in G.O.Ms.No.436, General Administration (Services-D) Department, dated the 15th October, 1996, as adapted in G.O.Ms.No.196, General Administration (Services-D) Department, dated the 28th May, 2016 and published in Part-I Extraordinary Issue of the Telangana Gazette No.97, dated the 28th May, 2016 and as subsequently amended from time to time:-

AMENDMENTS

In the said rules, in rule 22, in sub-rule (2):-

- (1) in clause (a):-
 - (i) in sub-clause (i), for the words "six shall be reserved for Scheduled Tribes", the words "ten shall be reserved for Scheduled Tribes" shall be substituted;
 - (ii) in sub-clause (i), the word "fifty" shall be omitted;
 - (iii) in sub-clause (ii), for the words "six for Scheduled Tribe employees", the words "ten for Scheduled Tribe employees" shall be substituted.
- (2) in clause (b), the word "fifty" shall be omitted.
- (3) in clause (c), the words "fifty or the case may be, forty seven" shall be omitted.
- (4) in clause (d), the words "fifty, as the case may be, forty five" shall be omitted.

- (5) in clause (e),-
- (i) against roster points 15, 42, 67 and 92, for the category "open competition", the category "Scheduled Tribes" shall respectively be substituted;
 - (ii) against roster points 33 and 75, for the category "Scheduled Tribes", the category "Scheduled Tribes (Women)" shall respectively be substituted;
 - (iii) against roster point 58, for the category "Scheduled Tribes (Women)", the category "Scheduled Tribes" shall be substituted.
- (6) in clause (i),-
- (a) for the expression "shall exceed 56% of the total number of vacancies", the words "shall exceed such percentage of the total number of vacancies, as may be specified", shall be substituted;
 - (b) for the expression "in excess of 56% of the total number of vacancies", the words "in excess of such percentage of the total number of vacancies, as may be notified", shall be substituted;
 - (c) in the proviso thereunder, for the expression "5% for the Scheduled Tribes", the expression "10% for the Scheduled Tribes" shall be substituted.
